## **NOTE SHEET**

As per the routine process for engagement outsourcing services of Watch and Ward, an advertisement was given in daily Hindi & English Newspaper "Amar Ujala" & "Tribune" dated on 15.02.2021 for registration of Firms for the Finance Year 2021-22 for various service like Watch & ward, Lab material, Sports, Printing of question papers etc. and the dead line for registration of Firms were given 16.03.2021.

Only four (04) firms for Watch & Ward was registered and the approval was given by Hon'ble Chairman, VMC vide letter No. 240346/VMC/KVC-II/2020-21 dated 16.03.2021 for further process.

Later, the quotations were called from the four (04) registered firms vide letter No.: F.240288/2-49/tender/KVC-II/2020-21/21-25, DATED: 19/03/2021 and last date has been taken 05/04/2021 by 3:00 pm.

After past the last date only two (02) firms was received which were not enough for awarding the service. Further, the date was extended after approval taken from the Chairman, VMC and new date was kept on 26.04.2021 for opening the tender for further processing.

However, only 3 firms have submitted their bids. Committee evaluated the technical bid of four (3) bidders w.r.t. criteria, laid down in tender document and prepared technical bid comparative statement. (Annexure-I enclosed)

From the comparative statement, the committee has observed following:-

Two (2) firms i.e. (1) M/s Round Dee clock Hawk Eye Securities PVT. LTD. Hamirpur (HP), (2) M/S RAPID Service Agency 1st Floor, Sohum, Complex, 100 feet Road, Bhatinda (PB)-151001] have submitted the required document w.r.t. criteria, laid down in tender document, which are found technically responsive.

But the (3) M/S Whizkids, the Service Providers, 36 Rajinder Nagar, Near Sham Nagar Gurudwara, Ambala Cantt-133001 did not submitted the PSARA certificate/License to work in the Chamba Distt. or in the whole Himachal Pradesh. While in the inviting Bit at Sr. No. 07 under point (a) it is clearly mentioned that the firm should provide the PSARA certificate/License in the proper format and should operating in the Chamba Distt. or in the whole Himachal Pradesh state.

The contract for Watch & Ward may be given to the previous firms.

Now, it is request to the hon'ble Chairman of the Vidyalaya Management Committee (VMC) to approve for the awarding the contract to the last firm, i.e. **M/s Round Dee clock Hawk Eye Securities PVT. LTD. Hamirpur (HP)**, for one more year i.e. 2021-22 for smoothening work.
